Christopher Steinocher is President and CEO of the St. Petersburg Area Chamber of Commerce. Prior to the Chamber, Mr. Steinocher was with the Tampa Bay Partnership as COO and Senior Vice President of Marketing and Business Development, a job he held for 17 years, helping start the regional economic development group. Mr. Steinocher was also the AVP of Marketing for Fortune Bank, a Tampa Bay based bank with 46 branch locations throughout He has over 33 years of experience in marketing and community development, 31 of which have been in the St. Petersburg region. He holds a Bachelor's degree from Emory University.

Mayor Ken Welch, City of St. Pete

Kenneth T. Welch was sworn in as the 54th mayor of St. Petersburg, Florida in January 2022.

Growing up in the Gas Plant area of St. Petersburg, Mayor Welch worked summers and after school on his grandfather's woodyard that sat on property later displaced by the interstate. His father was a city council member who helped lay the foundation for St. Petersburg's resurgence. Welch saw firsthand the uprooting of hundreds of businesses, homes, and churches for what eventually became Tropicana Field. He also saw the unfulfilled promises of jobs and economic development in return for that sacrifice.

After receiving his BA from USF St. Petersburg and MBA from Florida A&M University, Mayor Welch returned to St. Petersburg as an accountant for Florida Power Corporation. He also served as Technology Manager for his father's small accounting firm. After years of community service, Welch became the first Commissioner elected to represent County Commission District 7 in St. Petersburg, only the second African American commissioner in the history of Pinellas County. Welch proudly served on the County Commission for 20 years, where he brought a focus to the issues of economic development, transportation, equity, housing, criminal justice reform- and fighting poverty.

A third-generation resident of St. Petersburg, Mayor Welch and his wife, Donna, have two daughters.

Jason Spears was born in St. Petersburg and raised in Pinellas County.

After earning an Associate Degree in business from SPC, Jason graduated with a Bachelor of Science in Construction Management from the University of Florida.

After college, Jason moved to Atlanta and worked for a large general contractor specializing in multi-family high rise construction as well as healthcare for five years.

In 2009, he moved back to St. Petersburg to begin his career with Peninsular Mechanical Contractors, Inc. (PMCI) where he is the vice president and a shareholder. PMCI celebrated its 45th anniversary earlier this year.

Jason's path with the St. Petersburg Area Chamber of Commerce began as a member of the Leadership St. Pete Class of 2012. He then served for two years on the planning committee and three years on the Board of the LSPAA. Jason is a past Chair of the SPYP and the Finance Committee and is now serving as Chair of the Board of Governors for the Chamber.

Outside of the Chamber, Jason is passionate about the construction industry, specifically addressing the labor shortage in the skilled trades. Jason serves on the executive committee for the Florida Gulf Coast Chapter of Associated Builders and

Contractors, the largest multi-disciplined apprenticeship training facilitators in the state of Florida. Jason has also held leadership positions at the state and national level with ABC.

Jason lives in St. Petersburg with his wife Cassandra.

Christian Hardigree is the Regional Chancellor of the University of South Florida St. Petersburg, located in beautiful St. Petersburg, Florida. She previously served as the founding dean of the School of Hospitality at Metropolitan State University of Denver (Denver, Colorado) and as the founding director of the Michael A. Leven School of Culinary Sustainability and Hospitality at Kennesaw State University (Kennesaw, Georgia).

Before joining Kennesaw State, Dr. Hardigree spent 15 years at the University of Nevada, Las Vegas and served in a variety of administrative roles, including as the Assistant President and Chief of Staff to the University President, the Associate Dean for Strategic Initiatives, the Department Chair for Hotel Management (twice), and as the Associate Athletic Director for Community Development and Special Projects.

During her tenure at UNLV, Dr. Hardigree was a tenured faculty member in the William F. Harrah College of Hospitality, teaching graduate and undergraduate courses in hospitality law, employment law, management, human resources, ethics, and diversity. She became a Teaching Fellow and later a Senior Teaching Fellow, was recognized with several awards for teaching and service, while compiling an impressive and nationally renowned research and scholarly engagement portfolio.

Dr. Hardigree serves on a variety of community initiatives, including as a member of the Board of Directors for the St. Petersburg Downtown Partnership, President of the Board for the St. Pete Innovation District, and an executive board member of the St. Petersburg Chamber of Commerce.

Rui Farias is a near lifelong resident of St. Pete, and now the Executive Director of the St. Petersburg Museum of History. He holds a BA in Journalism from USF and was a writer for the St. Petersburg Times before embarking on a 15-year career in PR and Marketing, including events for the Tampa Bay Rowdies and the 1994 FIFA World Cup. After a short stint in public facility management, Rui returned to his love of history, and St. Petersburg, by creating and teaching Pinellas County's first Florida History class for St. Petersburg High School.

In her role as Economic Development Manager, she oversees the City's Business Attraction, Retention and Expansion programs as well as the City's Main Street Program and Workforce Development Initiatives.

An industry veteran of 12 years, Caleb leads the sports development efforts for the destination by placing a priority on relationships in the community and tourism industry. During his time at the sports commission, Caleb has secured significant events including the WWE Royal Rumble and multiple World, National, and Collegiate Championships spanning across the sports of Baseball, Boating, Golf, Pentathlon, and Softball. In the current fiscal year, Caleb is responsible for delivering 187,000 room nights to the destination.

Dr. Sheron Brown is an award-winning and internationally recognized social innovator and total wellbeing expert. Her pioneering and innovative nature led her to create an award-winning app dedicated to connecting nonprofits in their local areas. As a tech entrepreneur, Dr. Brown mentors health start-ups, advising them on health equity and coaching frameworks. Dr. Brown has authored several books, including The Conscious Collaboration PathwayTM, The Wellness Purpose ConnectionTM, and most recently, a journal set for publication later this year.

During her time as the CEO and Executive Director of the Tampa Bay Health Collaborative, Dr. Brown utilized her expertise to bring awareness and education to local communities while promoting and advancing health equity.

A celebrated speaker, Dr. Brown has spoken in front of audiences of all sizes on the topics of wellbeing, health, purpose, and Conscious Collaboration. Her TEDTalk entitled "How Your Work Could Influence Your Well-Being" focuses on the idea that work is not really about the work as much as it is about becoming.

A graduate of Howard University, her education and background involve neuroleadership and integrative nutritional health. Dr. Brown is a trained coach and yoga instructor and holds certifications in Oneness Meditation, HeartMath stress, and wellbeing.

Dr. Brown believes there is a direct connection between purpose and our work. In her work, she often notes that illness, stress, or anxiety often indicates imbalance in some areas of a person's life. Her life's purpose is to walk in freedom and expansion while helping others realize they can do the same.

Brandi Gabbard represents District 2 on the St. Petersburg City Council. As a member of the City Council, Brandi has fought to make our community safer and stronger by increasing access to affordable housing, lowering the cost of flood insurance, fighting for small and local businesses, and working to help our neighborhoods be safer and more resilient in the face of climate change.

Originally from Indiana, Brandi and her husband Keith moved to St. Petersburg in 2003. Recognized as an expert in issues pertaining to neighborhood sustainability has awarded her opportunities to speak on the national stage including Capitol Hill. While she has served in various roles throughout her community the role she is most proud of is mom to her 13 year old son.

Jay Miller is a specialist in planning, development and leasing of urban and suburban retail centers and infill townhome projects in the Tampa Bay market. After twenty years focused on development of large mixed-use projects, Miller created his own company, J Square Developers in 2013. J Square completed the new retail center in St. Petersburg's busy 4th Street corridor for Trader Joes and the Vitamin Shoppe in 2015, and co-developed St Petersburg's first Whole Foods store which debuted in early 2024. In the past several years, J Square has also developed free standing stores for national retailers including Starbucks, O'Reilly Automotive, Wawa and Circle K.

In the residential arena, the company has completed and sold out Quattro Beach Drive and the Saint James Townhomes (8 units) in downtown St. Petersburg, both infill townhome projects. Currently under development is Strum Place on the city's west side.

In November 2019, the City of St. Petersburg awarded development rights for a major new mixed -use development on a strategic 2.2. acre block downtown to Edge Central Development Partners, a joint venture between J Square, DDA Development and Backstreets Investments. That project is now under development in joint venture with Ellison Development Partners. J Square also manages a closely held portfolio of retail properties in Pinellas and Manatee counties with a total value exceeding \$12 million.

Mr. Miller graduated from the University of Michigan and received his Master's degree in City and Regional Planning from the John F Kennedy School at Harvard University. Throughout his career, he has directed development and management of specialty retail and mixed-use projects ranging in size from \$2.0 million to over \$100 million.

Prior to establishing J Square, Mr. Miller was Sr. Vice President of Retail Development in Florida for Ohio-based Equity Incorporated, where he advised Nationwide Realty Investors on the planning and development of a 140-acre mixed use project in the suburbs of Tampa, Florida. He served for 11 years as Regional Vice President of Development and Asset Management for Steiner +Associates. Steiner is one of the nation's leading developers of suburban and urban retail town centers based on the principles of new urbanism. Mr. Miller's career in retail development began in Miami when he joined Contructa US, the French company responsible for the development of the pioneering CocoWalk project in in Coconut Grove. Mr. Miller is a Florida licensed real estate broker. He enjoys international travel, speaks French fluently and is conversant in Spanish.

Mr Miller is actively involved in the St Petersburg and Tampa Bay community, serving as Finance Committee Member and past Board President of Pinellas Habitat for Humanity. He is Immediate Past President and still serves on the Board of Gulfcoast Jewish Family and Community Services in Clearwater. Other past Board participation includes Bayfront Medical Center and its successor, the Foundation for a Healthy St. Petersburg (a health care conversion foundation). He is also a Board Member and Chair of the Housing and Land Use Committee for the St. Pete. Chamber of Commerce and of the Network of Jewish Human Service Agencies (a national board).

The airport's future will be studied by a committee established after the November vote that assured Albert Whitted's continued presence on the city's waterfront, Lesniak said. He said about 300 people work at Albert Whitted, where an estimated 224 aircraft are based.

Lesniak earned an associate's degree from St. Petersburg Junior College in 1990. While in school, he worked as a copy clerk for the St. Petersburg Times. He then went to Embry-Riddle Aeronautical University in Orlando, graduating in 1994 with a bachelor's degree in aviation business administration.
